Mayor Berry called the meeting to order at 6:05 p.m.

AND THAT the approving jurisdiction and authority for the Village Update and other electronic communications to residents shall reside within the sole discretionary authority of the Acting Municipal Coordinator, in consultation with contractor Campbell on an ad hoc basis, as determined to be necessary by the Acting Municipal Coordinator.

BE IT RESOLVED THAT Council hereby directs that the authority of approving jurisdiction over Agendas be within the sole purview of the Acting Municipal Coordinator, in consultation with contractor Campbell on an ad hoc basis, as determined necessary by the Acting Municipal Coordinator.

- The display will be under the control of the Lions Bay Fire Rescue department, which is capable of handling all exigencies, including but not limited to having suitable equipment to hand; and
- ii) Spectators will be kept a safe distance from firework takeoff and landing zones, by barrier; and
- iii) Staff will communicate this resolution in the Village Updates of June 23 and 30, 2023 to alleviate public misgivings in light of the fire ban.

1. As a former manager of an 8-person IT team supporting a high-security telecoms operation, I believe I have an adequate grasp of the municipality's IT requirements. As requested by the CEO, I met with Sea to Sky Network Solutions, our service provider, to discuss data security and backup, user access, application provision, hardware lifecycle, network connectivity and more.

If there is one provider shortcoming to fix, it is that their support systems are for their convenience, not ours. But I am satisfied that properly managed, the provider can meet our needs (not to say that those needs shouldn't regularly be put out to tender, nor that current costs shouldn't be audited).

Internal work is needed on user housekeeping, file naming convention, hardware rationalisation, directory taxonomy and other standard IT tasks, but there are no gaping holes.

- 2. Making a start on user housekeeping, pending establishing access levels (which will largely parallel the org chart), the current user matrix is provided below for Council's information. The most significant aspect of the matrix is that published public-facing email addresses change from name-based to functional roles: pwm@lionsbay.ca rather than kbuhr@lionsbay.ca.
- 3. Coming is a datafile project to:
 - a. Dedup then rename files to a universal naming convention
 - b. Normalise them into a directory structure that makes obvious where they go (today there are, for example, half a dozen places that might legitimately hold the documents pertaining to say an encroachment agreement)
 - c. Move them off a slow local file server into the cloud, specifically to Microsoft Sharepoint utilising OneDrive as the user client, offering better security and sharing, faster search, and better backup and audit trail.

Recommendation: THAT Council receive this report.

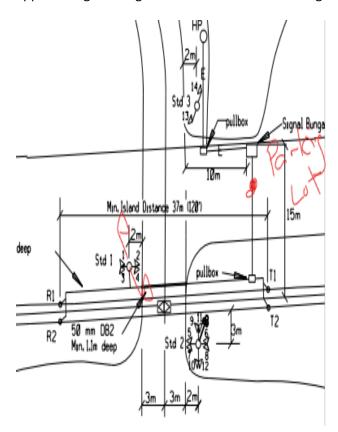

- 1. Further to this ongoing project, Council asked staff to a) report on what CN planned for the additional set of warning lights at the grade crossing of Lions Bay Ave, and b) consider alternative signage for the westbound Lions Bay Ave. grade crossing, to take into consideration the blind spots on the west side of the tracks.
- 2. CN responds that the additional lights will point at the parking lot, as existing lights do not cover vehicles turning from it toward crossing (Transport Canada Regulations require vehicles approaching crossing should be able to see front lights within stopping sight distance):





Construction is expected Q3 to Q4 2023, and CN will work with Public Works closer to the construction date if any closure required for the road.

3. CN could not commit as to where their jurisdiction ends and the municipality's begins, but suggested that even if we placed a Stop sign further away from the crossing on the east side, Transport Canada still may not like it as it might still create confusion. CN (and several residents) suggested a Road Crosses Rail warning sign:





4. BUDGET CONSIDERATIONS

Amalgamatiing he Stop sign project with the Second Set of Light project, Lions Bay will be expected to cover half of the cost of the lights, at \$11,744 if CN's application for a 50% Transport Canada grant is successful, to \$23,488 if it is not.

- Enable community-specific action to reduce emissions and increase climate resilience

- Enable knowledge sharing among local governments and Modern Treaty Nations to promote innovative climate action across the province

- 4. Report on projects linked to one or more objectives from the <u>CleanBC Roadmap to 2030</u> and/or draft <u>Climate Preparedness and Adaptation Strategy (CPAS)</u>.
- 5. Have the Chief Financial Officer, or equivalent position, submit and publicly post:

- a completed and signed attestation form to confirm all funds were, or will be, used towards climate;
 and
- a completed PDF version of the required program survey.

Note: The first year of this program is designed to disburse funding efficiently and support timely local climate action. Additional program and reporting refinements will be made in collaboration with local governments and Modern Treaty Nations for the second year of the program and beyond.

1. ABOUT THE PROGRAM

1.1 OVERVIEW

In 2018, the province introduced <u>CleanBC</u> - a pathway to a more prosperous, balanced and sustainable future. The <u>CleanBC Roadmap to 2030</u> (the Roadmap), released in 2021, builds on this plan and charts a path for B.C. to achieve its 2030 greenhouse gas (GHG) emissions reduction targets, while laying the groundwork for achieving net zero emissions by 2050.

The Local Government Climate Action Program (LGCAP) is a commitment within the Roadmap, and will provide predictable, annual, and long-term funding for local governments and B.C. Modern Treaty Nations to take climate action aligned with provincial and local climate objectives. Eligible communities will be required to report on the climate actions they take as a result of receiving funding.

LGCAP funding will enable B.C. communities to prepare for a changing climate, and for local climate action to contribute to reaching B.C.'s 2030 emissions reduction target and ultimately achieving net zero emissions by 2050.

Scope and Objectives

Local governments are climate leaders and key partners to achieving local, provincial, and national climate goals. According to B.C.'s 2030 sectoral emission reduction targets, buildings & communities must reduce emissions by at least 59 percent to 64 percent below 2007 levels. Since local governments directly or indirectly influence approximately half of all Canadian GHG emissions, bolstering local governments' climate action capacity is key to achieving targets.

The cumulative effect of local government efforts to reduce GHG emissions and address climate risks should not be under-estimated. Reaching net zero and adapting to a changing climate will require a whole-of-society approach. The program aims to catalyse the efficient flow of financial resources, data and knowledge between local governments and the Provincial government to allow for cost effective, impactful, appropriate, and locally owned and implemented climate action.

Information collected enables the Province to track progress, highlight climate leadership and advance action by including local government and Modern Treaty Nation emissions reporting data in the annual <u>Climate Change</u> Accountability Report.

All information gathered will help to inform policy development, monitor progress on achieving provincial and local climate objectives, and ensure that funds provided are used for these objectives.

2. ELIGIBILITY AND REPORTING REQUIREMENTS

2.1 ELIGIBILITY

Eligible communities include:

B.C. Local Government: Participants must be a municipality or regional district established by or under British Columbia statute.

Modern Treaty Nation: There are eight Modern Treaty Nations. There were originally seven First Nations implementing modern treaties that were negotiated in the made-in-B.C. treaty negotiations process: the five Maanulth First Nations, Tla'amin Nation, and Tsawwassen First Nation. Maanulth is structured as five independent governments and is counted as such by the Nisga'a treaty was concluded as the B.C. treaty negotiations process was unfolding. As such, there are in total eight constitutionally entrenched modern treaties in B.C. when the Nisga'a treaty is included.

2.2 **ELIGIBILITY REQUIREMENTS**

- 1. Be a signatory to the B.C. Climate Action Charter or a B.C. Modern Treaty Nation.
- 2. Measure and report on corporate GHG emissions or set up for mandatory measurement and reporting in year two. Please see the Provincial <u>guidance</u> on current best practices for quantifying and reporting GHG emissions.
- 3. Demonstrate climate investment (i.e., matching funding or in-kind contributions) equivalent to 20% of the provincial funding received. Many program participants are currently investing in emissions reductions and/or climate adaptation in their communities, and the 20% requirement is to show current investments (participants will receive 100% of their allocation even if current action is limited). The intent is to show past, current, and future investments in climate action and create awareness and education.
- 4. Report on projects linked to **one or more** <u>CleanBC Roadmap to 2030</u> and/or <u>CPAS</u> objectives including, but not limited to:
 - **Buildings:** Step code adoption, carbon pollution standard, energy efficient/demand side management programs, zero carbon heating requirement and/or net zero buildings commitments.
 - <u>Transportation:</u> Active transportation plan or investments, secure bike parking, commute reduction programs, transit/pedestrian-oriented development regulation, electric vehicle charging infrastructure plans or number of public installations, trip reduction programs, mode shift targets in Official Community Plan and/or Regional Growth Strategy.
 - <u>Community climate planning and related investments:</u> Compact & energy efficient community planning, organic diversion, completed climate or energy emission plan, and renewable energy investments.
 - <u>Climate resilience:</u> Assessment of current and future climate risks and plans to address risks through local government planning, programming, service delivery, asset management and other functions.
 - <u>Education and awareness:</u> Communications (newsletters, website content), engagement with constituents on climate-related matters, or educational programming (i.e., through rec centers).
- 5. Have their Chief Financial Officer, or equivalent position, submit and publicly post:
 - a completed and signed attestation form to confirm all funds were, or will be, used for climate action
 - a completed PDF version of the required program survey

IMPORTANT INFORMATION:

Eligible expenditures are determined by local governments as long as they are linked to CleanBC Roadmap and CPAS objectives. Expenses can include staffing, contracts, investments to improve energy efficiency, climate infrastructure, matching funds to leverage federal government and other third-party funding, and engagement.

Funds can be held in reserve over fiscal years to fund larger projects, but funds disbursed in fiscal year 2022/23 must be spent by March 31, 2025.

3. REPORTING PROCESS

3.1 OVERVIEW

Information collected enables the Province to track progress, highlight climate leadership and advance action by including local government and Modern Treaty Nation emissions reporting data in the annual <u>Climate Change Accountability Report</u>.

All information gathered will help to inform policy development, monitor progress on achieving provincial and local climate objectives, and ensure that funds provided are used for these objectives.

Note that if all requirements are not met in this first year of the program, funding will still be provided to enable program participants to prioritize climate action (eligibility requirements numbers 1, 3 and 5 listed in section 2.2 must be met). However, for a community to be eligible for funding in year two and beyond, all requirements will have to be met. This guide will be updated accordingly prior to the second year of the program.

Reporting requirements include completing an online survey (i.e. online reporting), completing, signing and returning the attestation form, and publicly posting it along with the survey information.

The first year of this program is designed to disburse funding efficiently and support timely local climate action. Additional program design and reporting refinements will be made in collaboration with local governments and Modern Treaty Nations for year two.

3.2 ONLINE REPORTING

Before the reporting period opens, each local government and Modern Treaty Nation will receive an email with instructions on how to access the online tool to complete the reporting requirements.

3.3 ATTESTATION FORM & PROGRAM SURVEY REPORT

By September 30, 2022, each local government and Modern Treaty Nation must publicly post a completed PDF version of the required program survey and a completed and signed attestation form.

Supplementary documents

Links (URLs) to supplementary documents such as strategies and plans can be included in the online survey.

APPENDIX A: GLOSSARY OF TERMS

Adaptation

Adjustment in natural or human systems in response to actual or expected climatic stimuli or their effects, which moderates harm or exploits beneficial opportunities.

Anthropogenic greenhouse gas emissions

Greenhouse-gas emissions resulting from human activities.

B.C. Climate Action Charter

A voluntary agreement signed by local governments in British Columbia. Signatories commit to working to achieve three goals: becoming carbon neutral in respect of their corporate operations; measuring and reporting on community GHG emissions; and creating compact, complete and energy-efficient communities.

Carbon dioxide equivalent (CO₂e)

The universal unit of measurement to indicate the global warming potential (GWP) of each of the six greenhouse gases, expressed in terms of the GWP of one unit of carbon dioxide. It is used to evaluate releasing (or avoiding releasing) different greenhouse gases against a common basis.

Climate

The long-term statistical average of weather-related aspects of a region including typical weather patterns, the frequency and intensity of storms, cold spells, and heat waves. Climate is not the same as weather. A description of the climate of a certain place would include the averages and extremes of such things as temperature, rainfall, humidity, evapotranspiration, and other variables that can be determined from past weather records during a specified interval of time.

Climate change

Refers to changes in long-term trends in the average climate, such as changes in average temperature.

Climate hazard

A physical process or event (e.g. flooding, sea level rise, storm surge events) that can harm human health, livelihoods, or natural resources.

Climate initiatives

Actions that reduce greenhouse gas (GHG) emissions and/or strengthen resilience and the ability to adapt to climate-induced impacts This includes (but is not limited to): climate-related hazards; integrating climate change measures into policies, strategies and planning; improving education, raising awareness of climate change causes and solutions, increasing human and institutional capacity with respect to climate change mitigation and adaptation, and impact reduction and early warning systems.

Climate resilience

The ability to anticipate, prepare for, and respond to hazardous events, trends, or disturbances related to climate. Improving climate resilience involves assessing how climate change will create new, or alter current, climate-related risks, and taking steps to better cope with these risks.

Climate Risk and Vulnerability Assessment

The purpose of the Climate Risk and Vulnerability Assessment (CRVA) is to develop an understanding of current and future climate risks. The CRVA will inform the inclusion of adaptation goals and actions in a climate action plan. Climate risk arises as a result of the confluence of hazards, exposure, and vulnerability. In other words, a climate hazard becomes a climate risk when inhabitants and/or assets are exposed to the particular hazard and if those exposed inhabitants or assets are vulnerable to it. The region can improve its resilience and adaptive capacity to climate-related shocks and stresses by implementing climate adaptation actions. However, it is advisable to develop a sound understanding of context-specific climate risks before developing such actions.

CO_2

Carbon dioxide, which is one of several greenhouse gases.

Emissions

The release of substances (e.g., GHGs) into the atmosphere. Emissions occur both through natural processes and as a result of human activities.

Community emissions

Greenhouse gas emissions generated from community activities.

Corporate emissions

Greenhouse gas emissions generated through local government operations.

Global warming potential (GWP)

An index representing the combined effect of the differing times greenhouse gases remain in the atmosphere and their relative effectiveness in absorbing outgoing infrared radiation.

Greenhouse gases (GHGs)

The atmospheric gases responsible for causing global warming and climate change. The major GHGs are carbon dioxide (CO_2), methane (CH_4) and nitrous oxide (N_2O). Less prevalent -- but very powerful -- greenhouse gases are hydrofluorocarbons (HFCs), perfluorocarbons (PFCs) and sulphur hexafluoride (SF_6).

Greenhouse gas (GHG) inventory

A GHG inventory is an accounting of the amount of GHGs emitted into or removed from the atmosphere over a specific period of time (e.g., one year). A GHG inventory also provides information on the activities that cause emissions and removals, as well as background on the methods used to make the calculations. Policy makers use GHG inventories to track emission trends, develop strategies and policies and assess progress. Scientists use GHG inventories as inputs to atmospheric and economic models.

Local government

In British Columbia, a term that includes both regional districts and incorporated municipalities.

Local government corporate emissions boundary

GHG emissions produced as a result of a local government's delivery of "traditional services," including fire protection, solid waste management, recreational/cultural services, road and traffic operations, water and wastewater management, and local government administration.

Mitigation

Climate change mitigation refers to actions or activities that limit GHG emissions entering the atmosphere and/or reduces their levels in the atmosphere. Mitigation includes any activity that reduces or limits GHG emissions, such as energy production and use, or sequestration, which removes emissions from the atmosphere through land use or other (including artificial) mechanisms.

The ultimate goal of mitigation is to preserve a biosphere which can sustain human life and supporting ecosystems. This means reducing anthropogenic GHG emissions towards net zero to limit the warming, with global goals agreed in the Paris Agreement. Effective mitigation strategies require an understanding of mechanisms that underpin release of emissions, and the technical, policy and societal options for influencing these.

The Paris Agreement

The legally binding international treaty on climate change. It was adopted by 196 Parties at COP 21 in Paris, on December 12, 2015 and entered into force on November 4, 2016. Its goal is to limit global warming to well below a 2-degree Celsius increase in temperatures (and preferably 1.5 degrees Celsius) compared to pre-industrial levels.

The Paris Agreement is a landmark in the multilateral climate change process because, for the first time, a binding agreement brings all nations into a common cause to undertake ambitious efforts to combat climate change and adapt to its effects.

Vulnerability

The degree to which a system is susceptible to, or unable to cope with, adverse effects of climate change, including climate variability and extremes. Vulnerability is a function of the character, magnitude, and rate of climate variation to which a system is exposed, its sensitivity, and its adaptive capacity.

Zero carbon construction

Tackling operational and embodied carbon emissions from the building and construction sector. It requires deep collaboration across the entire value chain, and radical transformation in the way buildings are designed, built, occupied and deconstructed. It requires new business models that promote circularity, re-use of buildings and materials, whole lifecycle thinking, high performance operations, and ultimately a shift away from fossil fuels.

Zero emission vehicles (ZEVs)

A vehicle that has the potential to produce no tailpipe emissions. They can still have a conventional internal combustion engine but must also be able to operate without using it. The following vehicles are considered ZEVs: battery-electric, plug-in hybrid electric and hydrogen fuel cell.

APPENDIX B: EXAMPLES OF CLIMATE INITIATIVE

Regional Energy Efficiency Program

The Central Kootenay Regional District is committed to reducing greenhouse gas emissions and saving energy. The Regional Energy Efficiency Program has three options for saving energy and money in homes. Participants can access support through the process such as energy advisors, contractors, rebates, low interest financing, and next steps.

The East Kootenay Energy Hub (the Hub)

Facilitated by the Community Energy Association, the Hub is raising awareness of energy efficient solutions for East Kootenay residents. Supports for new home construction, home renovations, and electric vehicle initiatives are provided. The Hub has resources for builders, homeowners, realtors and local governments to make more informed choices about energy efficient options in new and existing buildings.

Electric Vehicle (EV) Charging in Richmond

To support access to residential zero emission vehicle charging, in December 2017 the City of Richmond began requiring energized zero-emission vehicle charging outlets capable of supporting a Level 2 charger in each parking space in a new building. Richmond has public EV charging stations throughout the community so when you visit a city facility, you can charge your vehicle. EVs are an important component of a more sustainable Richmond, and supporting increased adoption of EVs through convenient access to charging stations is an important action in Richmond's Community Energy and Emissions Plan.

Victoria's All Ages and Abilities (AAA) Cycling Network

Victoria is building a network of all ages and abilities (AAA) cycling routes across the city. The AAA cycling network plan was adopted in 2016 and the city is aiming to complete all projects by 2023. Once the network is complete, 95% of the municipality will be within 500m of a AAA cycling route, providing safe and convenient access to village centres, parks, recreation centres and schools.

A New Climate Action Plan for Port Coquitlam

Building on the City's 2010 Corporate and Community Climate Action Plan, Port Coquitlam plans to adopt a comprehensive new made-in-PoCo Climate Action Plan in 2022 combining input collected over fall 2021 – from the public, Council, kwikwaham (Kwikwetlem) First Nation and other key stakeholders – with climate science, research, and technical data.

Fernie Food Action Strategy

This project arose at a time when the global pandemic highlighted the importance of a local supply chain, food access and a robust local agriculture. Input gathered from residents, farmers, processors, gardeners, and City of Fernie staff resulted in four actionable recommendations: 1) Promote growing food not lawns 2) Allow backyard hens citywide 3) Encourage rainwater utilization 4) Support local commercial agriculture.

Tsay Keh Dene Nation and the Carcross/Tagish First Nation Community-Based Climate Monitoring project

Chu Cho Environmental partnered with Tsay Keh Dene Nation and Carcross/Tagish First Nation to explore the local impacts of climate change and establish community-based climate monitoring programs in each Nation. Using both traditional knowledge and western science data, the team assessed the historic baseline climate, quantified changes on the land to date, and generated projections for how the climate may continue to change in the future. This project also explored how to increase community engagement and interest in climate change, with a focus on youth involvement and knowledge sharing between generations. Finally, this project serves as an essential first step in the establishment of long-term community-based climate monitoring programs in each Nation.

Climate Action Revenue Incentive Program Annual Summary Reports (2010-2018)

The annual summary reports highlight local government climate actions (2010-2018) reported for this program. The program provided funding to local governments that signed the B.C. Climate Action Charter equal to 100% of the carbon taxes they paid to support local government operations.

Vancouver, Quebec and Montreal have banned the use of glyphosate as well as other cities and countries around the world. This includes Mexico, Germany and France. And to note, Bayer of Germany, was the company that bought out Monsanto, the owner of Roundup.

Glyphosate could have been 'safe' if it weren't for it's off target effects, as like our medicine usually has side effects. It's mechanism of action is to shut down the shikimate pathway in plants which makes some of the essential amino acids, the building blocks of protein. Without these amino acids to make proteins, the plant dies. Human cells do not contain the shikimate pathway, hence 'safe' for humans. This pathway only exists in plants, and in fungi and bacteria that live in the soil and in our intestinal tract. The fungi, bacteria and other microbes in the soil make nutrients available to plant roots, which makes them strong, healthy and nutrient dense, to resist pests and disease naturally. The beneficial microbes in our gut do the same for us and determines human health. Glyphosate, being an antibiotic, as stated on the original patent, is antimicrobial, which means that it kills the beneficial microbes in the soil and in our gut.

Farmers use glyphosate as a weed killer, and a drying agent for grains and beans just before harvest.

Then there are GMO seeds and produce, that are designed to survive the direct chemical spray of this toxic chemical. Glyphosate can be absorbed through the leaves of these plants, so it can't be washed off. We are all consuming residues of glyphosate in our food. It seems to be in almost everything, wine, honey, boxed cereal, tampons and cotton sheets. GMO produce is in our grocery stores un-labelled. Glyphosate causes organ damage in livestock, kidney disease in agricultural workers, disrupts hormones and reproduction, has neurological impacts on children, and causes cancer. It is able to break open the tight junctions in our gut membrane as well as other membranes, such as the kidney tubules, blood vessels and the blood brain barrier. In the intestinal tract, some of the contents there are able to seep through the gut barrier and into the blood stream. Each time this happens, the immune system gets turned on which causes chronic inflammation, of said to be the root cause of disease. Glyphosate harms bees, butterflies, deer and other wildlife. Currently there are class action lawsuits in Canada and the United States against Bayer, for the toxic effects of glyphosate by home gardeners, farmworkers and landscapers. It would be best for all of us to find natural alternatives for everything we do.

Proposed Land Use Designation Amendment to *Metro 2050*Township of Langley – 23699 and 23737 Fraser Highway

The Township of Langley is requesting a Type 2 Amendment to *Metro 2050*, the regional growth strategy, for two properties located at 23699 and 23737 Fraser Highway, totaling 4.12 hectares. The proposed regional land use designation amendment would redesignate the site from Rural to Industrial to permanently allow for industrial uses granted under a temporary use permit set to expire in May 2024, as well as allow for additional industrial uses subject to meeting certain development prerequisites.

At its June 2, 2023 regular meeting, the Board of Directors of the Metro Vancouver Regional District (MVRD) adopted the following resolution:

That the MVRD Board:

- a. initiate the regional growth strategy amendment process for the Township of Langley's requested regional land use designation amendment from Rural to Industrial for the lands located at 23699 and 23737 Fraser Highway;
- b. give first, second, and third readings to "Metro Vancouver Regional District Regional Growth Strategy Amendment Bylaw No. 1365, 2023"; and
- c. direct staff to notify affected local governments as per section 6.4.2 of Metro 2050.

As required by both the *Local Government Act* and *Metro 2050*, the regional growth strategy amendment process requires a minimum 45-day notification period to allow all affected local governments and members of the public to provide comment on the proposed amendment. Following the comment period, the MVRD Board will review all comments received and consider adoption of the amendment bylaw.

The proposed amendment is a Type 2 amendment to *Metro 2050*, which requires that the public be provided with engagement opportunities as outlined in Section 6.4.4 in *Metro 2050* and that the amendment bylaw be passed by the MVRD Board by a two-thirds weighted vote. For more information on regional growth strategy amendment procedures, please refer to Sections 6.3 and 6.4 in *Metro 2050*. A Metro Vancouver staff report providing background information and an assessment of the proposed amendment regarding its consistency with *Metro 2050* is enclosed.

You are invited to provide written comments on the proposed amendment. Please provide your comments by September 8, 2023.

This is not the first time I have communicated my concerns regarding the removal of the stop sign at the rail crossing on Lions Bay Ave. (heading down the hill and over the tracks). And I do understand that a considerable amount of funds have been spent to see if it might be possible to NOT have this stop sign removed. Unfortunately, the concern for the safety of residents and visitors to our community (other than how it related to trains) was not addressed - what was addressed was the interaction of trains with vehicles! As we are all aware there is a considerable amount of traffic in addition of vehicles - kids, dogs, bikes, inner tubes, water wings, marina users and exploring tourists (first time visitors unfamiliar with our community.

The concern I have is to do with these things that were not addressed!

Earlier today I did a little tour of our community roads, and I would like to report that (with almost no exceptions) there were one or more stop signs at all intersections. Why?.....because they are needed to insure a level of safety that would not exist without them!

With the removal of the stop sign in question will make this area more dangerous for all users.

The flashing lights DO protect both trains and vehicles from accidents, but when there is NO train coming down the tracks, and thy are not flashing.....they do nothing to deal with the other safety issues - issues that are unrelated to trains!

The existing stop sign helps to insure that vehicles STOP and make sure it is safe to proceed before doing so.

What exactly can be done.....I am nor sure.....but making this highly used area of our community less safe is irresponsible.

Mayor and Council:

The influx of hikers to the Village has been astronomical and in the areas where access to the trails are located it is having a huge impact on residents. I was told last week by a resident that when told not to park in a specific location because they would receive a ticket, the hikers said "we'll just share the cost of the ticket amongst the group", others while parking in front of a fire hydrant and told by a resident not to park there have said "I'll just pay the ticket" and they don't move their car. Someone parked on a resident's property and left a note saying "we've just gone for a hike, hope you don't mind we parked here". Another resident stated that when talking to hikers who use the trails and camp overnight, they openly admit to having campfires. Campfires are being found unextinguished when hikers leave to hike back to their vehicles.

Our streets are not the parking lot at Grouse Mountain for the Grouse Grind or the parking lot at the Sea to Sky Gondola. These are our Village streets where we want to enjoy a nice quiet safe walk with our dog or our children, these are our homes where we want to enjoy a quiet time in our garden or on our deck. Instead we are faced on weekends, as soon as it is daylight, with constant cars and hikers, playing their music, talking loud and yelling to each other in their groups of 5-15 or more while they walk spread right across the roadway. When asked to move over to the side by a resident trying to drive past on a curve, they say "go around us". This huge increase in vehicular traffic is also having an affect on our street pavement in the various areas.

From the May 12 Village Update, Karl Buhr indicated, after he had been up to the water intakes with the staff: "Approaching a month into the job, I'm realising that once a sign has been put in place in a municipality, it's there forever unless someone questions if it's still needed. The community ends up looking like a sign farm rather than, well, a community. Public Works is going to take a hard holistic look at our sign population. Please nominate candidates for the cull."

I sent him an email saying please do not remove any signs that would prevent the Bylaw Officers from doing their jobs, as I was concerned it was the parking signage he was referring to. His reply: "My ask was more directed at non-parking signage like for example, "No Campfires," which I'd bet gives more people the idea than it prevents."

We recently survived a wildfire down just past lower Kelvin Grove that could have decimated the Village. If unextinguished campfires have already been found up the mountain trails in June, what is to happen as we enter summer? The rain we have had has not even penetrated the forest canopy to moisten the ground. If you dig down 4" into the ground in your yard, you'll find 1" of moist soil and below that it is just dry powdered dust! The thought is to remove some **No Campfire** signage in our forests and watershed because we don't want to appear to be a "sign farm" and the signs may just encourage people to have a campfire. A councillor and the mayor want to **reduce parking fines** because they are getting complaints from those who parked and got ticketed while they were hiking, or they didn't pay their fine and now the collection agency is charging them more. They want to do this for the hikers/the thrill seeking cliff jumpers/the beach goers who come to our Village. What about the

residents? We are being impacted by these things and it is increasing. A vehicle blocking a fire hydrant during a potential house fire! An unextinguished campfire could end up wiping out our forest and watershed, or even our entire Village. We also keep hearing at council meetings that the Parking Committee will be discussed at the "next" meeting and should be established soon. Summer is now upon us and everyone has been prompting council for action for months and months.

Disrespect by visitors to our Village, our watershed, our neighbourhoods and the residents is not acceptable any longer. Please put the residents and the Village first. What is council working on, and what plans are actively in progress to deal with the safety issues relating to all of the things mentioned here and stated directly to council from other very concerned residents?

Annual Municipal Report

According to the Community Charter, Council must present an Annual Municipal Report that includes an audited financial statement, and make it available for public inspection. Council must then consider the report and questions from the public during a meeting at least 14 days after public inspection and no later than June 30.

Why has there not been the usual process following budget completion, specifically an audited financial statement, public input and then an Annual Municipal Report. Last year during a May 3, 2022 Committee of the Whole meeting BDO Canada presented an audited financial statement and noted they were ready to issue a final audit report once Council approved. The timing is important since the audited financial statement is due May 15 each year. This year we are at the end of June with no information about an audited financial statement or annual report.
